Genetic mutation linked to a disease that blinds millions

WASHINGTON, D.C.-- The leading cause of blindness in the elderly -- age-related macular degeneration

(AMD) -- has been linked to a gene mutation, raising hopes of earlier detection and possible treatment.

Fifteen million Americans have the disease, and that number is expected to double as baby boomers age. Being able to relate a gene mutation to the likelihood of developing the illness may lead to better tests and eventually treatments, the scientists hope.

"I don't think it's going to be a year or two ... but I'd guess less than 10 years" before a treatment might become available, said Albert O. Edwards, a lead researcher.

Macular degeneration causes the central region of the eye's retina to deteriorate, damaging or destroying vision. For now, there are no broadly effective treatments, though a recently approved drug can slow the disease for some patients.

The new gene findings are reported in separate papers in this week's online issue of the journal *Science*. The three research groups were led by Edwards, at the University of Texas Southwestern Medical Center, Josephine Hoh of Yale University School of Medicine and Margaret Pericak-Vance of Duke University Medical Center.

While one mutated gene is not the only factor in macular degeneration, the discovery "is an important finding and will help in identifying individuals at risk, provide information to design future therapies [and] understand the process of degeneration," said Radha Ayyagari, a research investigator at the University of Michigan.

The teams examined the genes of patients with AMD and others without the disease. Researchers found that people with a variation in the CFH gene were more likely to have the illness. The CFH gene is involved in the production of a protein called complement factor H that helps regulate inflammation in a branch of the immune system.

Pericak-Vance, director of the Duke Center for Human Genetics, said her study indicated that the gene variant could account for about 43 percent of the risk of developing AMD for older adults.

"This gene opens the door to a whole new understanding of the factors that contribute to this disease," she said in a statement.

There are two forms of macular degeneration. The more common "dry" form progresses relatively slowly. The less common "wet" form, involving bleeding in the eye, can destroy vision rapidly. Both forms were associated with the CFH gene variation.

In December, the Food and Drug Administration approved the drug Macugen for treatment of the wet form of AMD. In studies for the drug, untreated patients had about a 45 percent chance of significant vision loss in a year compared with 30 percent for patients treated with Macugen
